Aur is k baad fauri wo naajayez taur se unhone domain ko hosting (jis ka zimma mein ne Mohammad Ibrahim k diya hua hai aur wo 20 saal say belauz aur khalis lillah ye khidmat anjaam dete aar rahe hain) se alag karke website ko down kardiya hai jiski wajah meri website fil waqt down hai aur musalsil 4 din say down padi hui hai. Mujhe fauri taur per usko active yani bahaal karna hai taake jo visitors usko visit karein wo usse istefaada haasil karsakein.
