

## Khalifatullahmehdi.info criminally hijacked!

Assalaamu Alaykum,

Dear subscribers,

As you may know, the website [www.khalifatullahmehdi.info](http://www.khalifatullahmehdi.info) was founded in 2005 by my long time friend and brother in faith Mr. Syed Mahmood Hasheer Ghazi with the intention to serve the Mahdavia community. At the same time I joined him in this project as a web developer to help actualize his vision of serving the community through this website. It was Mr. Hasheer who curated the material on the website including articles, multimedia files and literature. He collected the Mahdavia books and personally and solely funded the project for the digitization of the Mahdavia literature from old manuscripts, hand-written print copies into e-books and after the completion of each book's digitization, published them online and made them available on our website for the benefit of the community.

As Allah SWT is our witness this was done for His sake alone and not for any worldly recognition. It is the very reason that we always signed off on all of our work as 'Team Khalifatullahmehdi' rather than publicizing our names. Although some other people have also voluntarily contributed to the website over the past sixteen years like our brother Syed Muhammad Suhael, who deserves a special mention since his contributions in the capacity of a translator, well-wisher and advisor towards the progress and development of the website are simply unmatched. However, it should be noted that only Mr. Hasheer and I constitute the 'Team Khalifatullahmehdi' and others have simply been contributors to the website subject to the authorization of the 'Team Khalifatullahmehdi'.

Last year, Team Khalifatullahmehdi decided to change its hosting services and engaged the services of Syed Yousuf Tajammul Khundmiri of Splendid Planners & Developers, who posed as a sub-agent for Hostinger web hosting services. We had trusted Tajammul Khundmiri because he presents himself as a devout Mahdavi and also as an ardent disciple of one of the most esteemed Murshid of our community, Hazrat Syed Miranji Abid Khundmiri sahib of Channapatna. However, Tajammul Khundmiri in connivance with some other co-conspirators proceeded to defraud us by fraudulently and clandestinely changing the website's domain to his own credentials without our knowledge and this criminal act went undetected for almost a year.

Recently, Team Khalifatullahmehdi decided to update its homepage by posting the narrations of our master Imamuna Mehdi-e-Maood AS from Naqliyat Miyan Abdur Rasheed RZ and some corresponding excerpts from the central religious work of Mahdavia community, Aqeeda Sharifa by Hazrat Bandagi Miyan Syed Khundmir Siddiq-e-Vilayat RZ regarding the central and indisputable Mahdavia tenet pertaining the supremacy and supersedence of the Holy Quran over all other texts. The homepage also displayed a YouTube video (<https://www.youtube.com/embed/pwsbBAht8uU>) by Hazrat Syed Muhammad Sarfaraz Mehdi Tashrifullahi sahib on the same topic.

However, for some reason the command of our Imam AS didn't sit well with Tajammul Khundmiri and he contacted me and divulged the criminal act he had carried out last year and threatened me that if the homepage content was not removed within 6 hours, he would disconnect the DNS server link and thereby render the whole website inaccessible for subscribers and other community members. We never in our wildest dreams ever thought that we would be deceived by someone who presents himself as a pious Mahdavi and that the community will be held hostage by this immoral and unscrupulous man. He then proceeded to carry out his threat well before his own unlawful and unwarranted deadline of six hours had expired and rendered the website inaccessible. With this despicable act reeking of hubris and malignancy, Tajammul Khundmiri has shown himself to be in open opposition against the commandments of our master Imamuna Mehdi-e-Maood AS.

Furthermore, Tajammul Khundmiri and his co-conspirators, namely Dr. Noor Muhammad (Resident of KSA) and Noor Mehdi (resident of New Zealand) are now claiming ownership of the website. Ironically, Tajammul Khundmiri and his co-conspirators are now claiming that they have carried out this criminal act in the interests of the community. It escapes us how an act rooted in lies, deceit, fraud and impunity can ever be in the interest of the Mahdavia community. With this despicable act, not only have they violated several Quranic commandments like

4:135, 6:152, 23:8 and 33:58 among others but have also committed a crime punishable by the law of the land.

Since Tajammul Khundmiri and his co-conspirators claim to be the disciples of Hazrat Abid Khundmiri sahab, we contacted him through a telephone call and brought to his knowledge the crimes of Tajammul Khundmiri who claims to be his most ardent disciple. At the same time, we have also sent a letter containing the details of the crime to Hazrat Syed Taseen Khundmiri so that he can relay it to his father. Hazrat Abid Khundmiri sahab expressed shock and dismay upon hearing of the sordid actions of Tajammul Khundmiri and promised to intervene and make Tajammul realize the error of his ways and advise him to return and restore the trust i.e. the website to its original and rightful owner. Although Tajammul has shown outright aversion to the commands of our master Imamuna Mehdi-e-Maood AS, it remains to be seen whether or not he heeds to the sincere and pious advice of his Murshid, Hazrat Abid Khundmiri sahab.

If this last effort towards retrieving the website fails and Tajammul doesn't heed to the advice of his Murshid, then 'Team Khalifatullahmehdi' will pursue legal action against Tajammul Khundmiri and his fellow co-conspirators Dr. Noor Muhammad and Noor Mehdi. In conclusion, We apologize for the inconvenience caused by these criminals and thank you for your patience while we look into alternative avenues to continue to serve our community readership.
